The individual payment instructions so authorised must be issued and delivered as follows:

- **This Authority and Mandate refers to our contract** as dated as on submission and/or signature hereof ("the Agreement"). Further, if there are insufficient funds in the nominated account to meet the obligation, you are entitled to track my account and re-present the instruction for payment as soon as enough funds are available in my account.
- **Annually:** on or after the dates when the obligation in terms of the Agreement is due, and the amount of each payment instruction may not be more than the obligation due.
